HUPAC is the Political Action Committee of the National Association of Health Underwriters (NAHU). It is the expression of our First Amendment rights to free speech and association guaranteed under the Constitution. Such political expression has become a far more than useful option for professionals in a heavily regulated business like health insurance. Since NAHU and similar organizations are prohibited from making political contributions, HUPAC was created to allow contributors to combine their financial support to achieve maximum effect in the halls of Congress.

Why is HUPAC Necessary?

Few other industries are as heavily regulated as health insurance. Therefore, YOUR success, and that of YOUR clients, is directly dependent upon the actions of Congress. It is absolutely critical that we help those Congressional candidates who support private sector health insurance.

To Whom Does HUPAC Contribute?

HUPAC Contributes to majority and minority party candidates, incumbents and challengers alike. Because it is non-partisan, it does not represent the interests of any political party.


