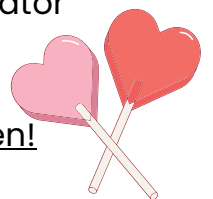

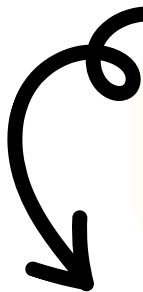

employer reporting

ISSUE SUMMARY:

The requirements for employers to report health plan information to the federal government are confusing and extremely complicated. We are concerned that many employers could choose to stop offering health insurance coverage to their employees because the compliance burden is too much for their business to bear.

ACTIVE LEGISLATION:

- *H.R. 1264: Representatives Adrian Smith (R-NE) and Mike Thompson (D-CA)*

ACTION NEEDED:

Congress should take action to ease the reporting requirements under Section 6055 and 6056 for employers by establishing a new voluntary reporting system, reduce the number of individuals and amount of information that would need to be reported, and eliminate the requirement to collect dependent social security numbers.
